During the five-year period the CSP shall update the information contained in its application, including increases or decreases in participation by end-use customer(s) in PJM's Demand Response programs, as and to the extent necessary so that the information contained in the application remains accurate and complete and so that CPP has a current and accurate record of the aggregate demand of all CPP customers participating in PJM programs.
